
WEBSITE CONFIDENTIALITY CHARTER

Article 1: General principles

1. Nomics SA, having its head office at Rue des Chasseurs Ardennais 4, 4031 Angleur, Belgium, registered at the Crossroads Bank for Enterprises (CBE) under the number 0477566335, hereafter "Nomics", operating the following Website via www.nomics.be, hereafter the "Website".
2. All personal data collected by us (hereafter referred to as "Data") will be processed in with the applicable Belgian and European regulations relative to the protection of personal data in particular Regulation (EU) 2016/679 of the European Parliament and of the Council on 27 April 2016, on the protection of individuals with regard to the processing of personal data and on the free movement of such data and revoking Directive 95/46/EC (General Data Protection Regulation, GDPR), Directive 2002/58/EC, amended by Directive 2009/136/EC and the Act of 13 June 2005 known as the "Electronic Communications Act" of June 13th, 2005, amended by the law of July 10th, 2012.
3. You are invited to read this Confidentiality Charter (hereafter the "Charter") attentively and familiarize yourself with its contents.

Article 2: Scope of application

1. The Charter describes the measures implemented for the use and management of your Data in the framework of Website use, and your rights as a Website user.
2. The Charter applies to all services offered by Nomics via the Website.

Article 3: Data likely to be collected

1. When you register on our Website, we collect information (including Data) that you provide to us as users. We collect the Data you provide on the Website for the sole purpose of enabling Nomics to process and fulfil your orders, and to provide you with adequate after-sales technical support.

Article 4: Purpose of the Data processing

1. The data we collect is used to process the execution and follow-up of your orders and the resulting services (invoicing, delivery, technical after-sales support).
2. We may use your email address to send you an important scientific publication about the technology developed by Nomics or to let you know that we have information material at your disposal. These rare notifications will no longer be sent to you upon your simple request.
3. We may also use these Data to improve our services.
4. We may anonymize the Data by removing personally identifiable information such as name and aggregate the data only for the purposes of scientific research or Research and Development.
5. We do not permit the sale or transfer of this Data to third parties.

Article 5 : Right of opposition

1. You have the right to object to the processing of your Data. This right can be exercised by sending a letter to the Nomics headquarters: Christine Borlée, GDPR management, Rue des Chasseurs Ardennais 4, 4031 Angleur, Belgium OR by email at the following address: gdpr@nomics.be.

Article 6 : Right of access, rectification, deletion and limitation of processing.

1. You have the right to access and rectify the Data concerning you. You may also ask us to delete, correct and limit the processing of this Data, in accordance with articles 15, 16, 17 and 18 of the GDPR, within the limits of the legal obligations to keep accounting and tax documents.

Article 8 : Cookies

1. Cookies are data that are sent to your device from your browser when you visit the Website and that includes a unique identification number.
2. We only store session cookies. In accordance with the law of 13 June 2005 relating to electronic communications, your agreement is not necessary when the sole purpose of installing a cookie is to enable or facilitate electronic communication, or is strictly necessary to provide an online service at your express request, as is the case on the Website.

Article 9 : Securisation

1. In order to ensure the protection of the Data collected, we have set up a program to secure the information stored in these systems. In addition, our computer systems are equipped with data encryption and software protection.

Article 10 : Data storage

1. Nomics may keep your data for a legal archive period related to the obligations in the event of a tax audit.

Article 11 : Right of complaint

1. Without prejudice to any other administrative or judicial remedy, you have the right to lodge a complaint with a supervisory authority, in particular in the Member State of your habitual residence, place of work or place of the alleged breach if you consider that the processing of your data has infringed the GDPR.
